



Paws-a-Palooza, LLC
WAIVER OF LIABILITY

Paws-a-Palooza, LLC (hereafter referred to as Paws-a-Palooza), and the owner of the dog(s) to be admitted into daycare or boarding (hereafter referred to as Owner) hereby agree as follows (INITIAL ALL LINES, SIGN & DATE):

_____ Paws-a-Palooza reserves the right to not accept a dog into day camp or boarding for any reason. All rules of the facility are subject to change at the sole discretion of Paws-a-Palooza.

_____ Owner certifies that to the best of his/her knowledge, the dog's vaccinations are current, and the dog is in good health, not having been recently exposed to any contagious canine illnesses prior to any future stays at Paws-a-Palooza for a minimum of 10 days.

_____ In admitting the dog to Paws-a-Palooza, Owner understands and agrees that Paws-a-Palooza, its officers, owners, employees and agents have relied upon Owner's representations that the dog is in good health and currently vaccinated and Owner's representations regarding the dog's behavior history.

_____ Owner understands that all pets entering Paws-a-Palooza will be examined for fleas. If fleas are found, flea treatment will be administered and a \$20 charge will be added to Owner's bill. Owner can opt to pay a \$10 fee upon arrival and Paws-a-Palooza will administer flea treatment if they are not sure if their pet has fleas.

_____ Paws-a-Palooza will exercise reasonable care of the dog during its stay. Owner does acknowledge and he/she understands that their dog will co-mingle with other dogs, and that as a result their dog could incur small cuts, scrapes, or other minor injuries in the course of normal dog play. In consideration of these services, Owner expressly waives and relinquishes any claims against Paws-a-Palooza, its officers, owners, employees and agents, relating to services provided pursuant to the Owner's dog, except those claims arising from willful misconduct by Paws-a-Palooza, and further agree to indemnify Paws-a-Palooza against all such claims.

_____ Owner further understands and agrees that in the event of an emergency, Paws-a-Palooza is authorized to seek emergency veterinary care as Paws-a-Palooza deems necessary and Paws-a-Palooza is hereby released from all liabilities related to the transportation, treatment and expense relating thereto.

_____ In the event of death of Owner's dog while under the care of Paws-a-Palooza, Owner authorizes Paws-a-Palooza to have the body taken to a veterinarian for storage, at Owner's expense, to await disposition instructions from Owner.

_____ Owner agrees to pick up his/her dog by 6:00 pm (M-F) and understands that Owner will be charged a fee of \$10 for any dog not picked up by 6:30pm and \$20 for any dog not picked up by 7:00pm. Dogs left after 7:00pm will be kenneled and can be picked up the following morning (7:00 am M-F, by arrangement on Sat-Sun). If dogs are not picked up within 3 days, or if Paws-a-Palooza does not receive contact from Owner during that period, the dog(s) shall be considered abandoned and Paws-a-Palooza will place the dog(s), at Owner's expense, as Paws-a-Palooza deems appropriate. Owner further agrees to release, hold harmless and indemnify Paws-a-Palooza for any claims relating to the transportation and kenneling of the dog(s) should Owner fail to pick up the dog for any reason prior to closing.

_____ Owner further agrees that in the event that Paws-a-Palooza should observe/suspect that his/her dog may appear to be ill in any way, as determined by Paws-a-Palooza or its staff, Paws-a-Palooza will require a Veterinarian's note verifying the health status of the dog before allowing the dog to return to the facility. Owner shall be responsible for picking up the dog from the facility within a reasonable period of time on the same day, after being notified by Paws-a-Palooza that his/her dog needs to be removed. The dog will not be allowed to return to Paws-a-Palooza until a Veterinarian has provided written health clearance. **No refund shall be issued for unused pre-paid daycare days.** Furthermore, Owner understands that no vaccination offers 100% protection from any disease, and that exposure to kennel cough is still possible even if the dog has received a Bordetella vaccination.

_____ Owner further agrees to the following conditions regarding intact dogs: Only individual play times will be allowed for these dogs in order to maintain the utmost safety for all dogs attending Paws-a-Palooza if it is deemed they are too assertive or aggressive for group play.

_____ Paws-a-Palooza will only accept dogs that are at least 4 months of age and have had all required vaccinations.

_____ Owner further agrees to the following conditions regarding pre-paid packages: Prepaid day camp/boarding packages are non-refundable. Pre-paid day camp/boarding packages expire one year from the date of purchase. Unused days will be forfeited and will not be refunded or honored after the one-year period.

_____ Owner gives permission for photos of their dog to be taken by Paws-a-Palooza staff for use in advertising and promotional materials and media. Paws-a-Palooza agrees not to sell or distribute these photos to any third party.

_____ Vaccinations and medical history: Bordetella vaccination 7-10 days prior to coming into the Paws-a-Palooza facility is required for all dogs attending day camp, boarding, grooming, and general visits. Bordetella vaccinations must be updated as recommended by your Veterinarian. Other required vaccines are rabies and DHLPP (distemper and parvo).

_____ Food must be brought in a labeled and sealed container. Medications MUST be brought in the original, vet prescribed container or accompanied by a letter from the veterinarian.

_____ Boarding reservations must be cancelled within 48 hours prior to arrival date. Failure to cancel a boarding reservation within 48 hours will result in a \$35 no call-no show fee. Boarding requires a credit card on file at the time of the reservation.
